Stronco will not be responsible for failure or delay in performing service when delay is caused by strike, labour stoppage, or any other cause unavoidable or beyond their control. The liability of Stronco is hereby limited to \$0.30 per pound per article; \$50.00 per item; or \$1000 per shipment. It shall be the owner's responsibility to secure and maintain loss or damage insurance coverage for their exhibit properties. **A 30% surcharge will be applied to all uncrated/loose materials to cover the extra time and care required to handle these shipments.**
