Occupational Health & Safety

NEW THIS YEAR: The Vancouver Convention Centre will no longer be providing complimentary high-visibility vests. Please bring safety vests for your entire team or be prepared to purchase them onsite.

Anyone working or visiting the show floor during move-in and move-out, regardless of their booth size or location on the show floor, MUST wear the following:

- High visibility vest. NEW THIS YEAR: The VCC will no longer be providing
 complimentary high-visibility vests. Safety vests are available to purchase at the
 Service Desk on the show floor or on through the <u>VCC Exhibitor Portal</u>; you are also
 more than welcome to bring your own safety vests.
- CSA approved steel-toed safety shoes (look for the green triangular patch).





Exhibitor Health & Safety Declaration

All exhibitors are required to submit the Health & Safety Declaration Form by the appropriate deadline. We kindly ask that you advise your staff, suppliers and exhibitors of the safety practices.

Exhibitor-Appointed Contractors

Any exhibitor who plans to use an independent contractor(s) other than the IDS Vancouver <u>Official Suppliers</u> must submit the Notice of Intent to Use Exhibitor Appointed Contractor (EAC) with a copy of the EAC's certificate of insurance. The EAC must comply with the requirements and regulations listed on the form. EAC's cannot perform the work of <u>Exclusive Suppliers</u>.
